TERMS & CONDITIONS

1. Member shall pay annual dues of \$30.00 to the Royce Gracie Jiu-Jitsu Network (payable with application). Member shall receive a membership card and may participate in any training session conducted by an authorized Representative of the Royce Gracie Jiu-Jitsu Network upon presentation of a valid membership card.
2. The member shall be allowed to participate in training sessions conducted by Representatives of the Royce Gracie Jiu-Jitsu Network. Such training sessions shall be for the purpose of allowing members to regularly meet with other individuals interested in Royce Gracie Jiu-Jitsu for the exchange of information and to practice techniques learned from Royce Gracie Jiu-Jitsu seminars, certified instruction, or videotapes. Member understands that such training sessions may not necessarily be conducted by an instructor certified by Royce Gracie to teach Jiu-Jitsu and may neither constitute lessons nor instruction in Jiu-Jitsu. Member will also be required to pay a participation fee of not more than \$80.00 per month to the Representative conducting the training sessions.
3. Membership is limited to individuals who have received instruction at a certified Royce Gracie Jiu-Jitsu seminar, through lessons with Royce Gracie or by use of the official Royce Gracie Jiu-Jitsu instructional videotapes. Member is required to attend a Royce Gracie Jiu-Jitsu seminar once a year or as available in Member's immediate geographic area.
4. Member acknowledges the training sessions to be unsupervised by an instructor certified by the Royce Gracie and further acknowledges that the content and form of such training sessions are neither controlled nor dictated by the Royce Gracie Jiu-Jitsu Network. Member understands that the training sessions will involve the practice of Jiu-Jitsu, which is a martial art. THE UNDERSIGNED MEMBER STATES THAT HE OR SHE IS OVER 16 YEARS OF AGE, DOES ASSUME THE RISK OF AN INJURY RESULTING FROM PARTICIPATION IN SUCH TRAINING SESSIONS and does release the Royce Gracie Jiu-Jitsu Network Representative, the Royce Gracie Jiu-Jitsu Network, KhonKhor Enterprises, Inc., and Royce Gracie from any liability or claim of liability which may arise as a result of injury received or alleged to be received by participation in such training sessions.
